AmeriHealth Caritas New Hampshire, New Hampshire Chapter of the American Academy of Pediatrics (AAP), and New Hampshire Department of Health and Human Services (DHHS) Division of Public Health are excited to launch a Quality Improvement Lead ECHO series — an emerging case-based learning model for practitioners. Twenty-five MOC Part 4 points are available for attending this series, as well as six Continuing Medical Education (CME) for physicians and six Continuing Education Units (CEU) for nurses. ### **What is Project ECHO?**

The “Extension for Community Healthcare Outcomes,” or ECHO model, was developed at the University of New Mexico Health Sciences Center and is now used nationwide in the United States and internationally.

### **What’s the goal of this program?**

The AmeriHealth Caritas New Hampshire ECHO program exists to:

1. Develop standardized protocols for lead testing through training and meeting with lead quality improvement (QI) experts to address individual practice needs.
2. Streamline testing procedures to increase point-of-care testing and ongoing screening of vulnerable populations.
3. Use data from participating offices to provide coaching sessions, celebrate successes, and identify areas for improvement.
4. Discuss available resources from the state and managed care organization (MCO) partners on billing and coding guidelines and point-of-care testing recommendations.



## When and how often will ECHO sessions take place?

AmeriHealth Caritas New Hampshire is now hosting a Quality Improvement Lead ECHO series in collaboration with New Hampshire DHHS and AAP.

Sessions will be ongoing and additional clinics will be established to address specific topics as the need dictates. All ECHO sessions will occur online from noon to 1 p.m. ET.
